Uppsala Auktionskammare's Data Protection Policy as of 8 April 2022

Points of departure

AB Uppsala Nya Auktionskammare ("UAK") attaches great importance to the protection of the privacy of Consignors, Bidders, Buyers and other persons who visit or otherwise have contact with UAK, whether digitally or by personal visit or otherwise.

Personal data and other data are collected in accordance with applicable laws and generally accepted auction practices and other industry practices. This means that, as a basic premise, the personal data collected will be treated confidentially in accordance with the provisions of this data protection policy.

The provisions of this policy apply in addition to the provisions on personal data and the processing and protection of personal data in the UAK Terms and Conditions for Buyers and the UAK Terms and Conditions for Sellers. These terms are available at www.uppsalaauction.se. In the event of any conflict between the Purchase Terms and Conditions/Sales Terms and Conditions and this Data Protection Policy, the Terms and Conditions shall prevail.

Anyone who visits the UAK website or showrooms or offices or contacts UAK by e-mail or who uses UAK's services in any other way accepts what is stipulated in this data protection policy and what is stipulated in the policy on the processing of personal data by UAK.

UAK's data protection policy does not apply to other websites, even if there are links to them on UAK's website. The data protection policies of such operators should therefore be checked before visiting their websites.

What is personal data?

Personal data is information about personal or factual circumstances relating to or identifying a specific person, such as name, postal address, e-mail address and the like.

Collection and processing of personal data

For visitors to the UAK website, UAK stores by default the IP address assigned to the visitor, information on the web page(s) visited, the time and duration of the visit and all data related to the submission of bids. In addition, information is stored on how the customer otherwise interacts electronically with UAK, including electronic identification through, for example, BankID. The same applies to information on how the UAK website is used (including language settings, browser settings, time zones, operating systems, platforms and screen resolutions, download errors and the like)

Physical documents stored include copies of identity documents.

In addition to the individual digitally or physically visiting UAK, personal data relating to name, address and other contact information may be collected from publicly available sources. Credit information may also be obtained regarding the person registering as a bidder in accordance with applicable legislation. Other personal data may also be collected from external sources if there are specific reasons.

Use and disclosure of personal data

UAK uses personal data provided by the individual and otherwise collected to the extent necessary for technical administration and development of UAK's web page and website, processing of consignments, administration of bidding at auctions, handling of other customer-related matters, prevention of crime and breach of contract and prosecution of suspected crimes, statistics and customer analysis and other investigations undertaken by UAK, statutory disclosure obligations and performance of other duties of public interest.

For those who do not expressly prohibit this, personal data provided and otherwise collected is also used to inform about UAK's services.

Cookies

It is normally possible to search anonymously on the UAK website. However, some information is only available to registered customers.

Cookies are small files that are automatically stored on the visitor's computer, telephone or other IT equipment used for communication with UAK. They make the UAK website easier to navigate and more user-friendly.

UAK uses cookies to learn about visitors' preferences and to optimize the design of the UAK website. UAK also uses cookies to find out whether the visitor has previously visited the UAK website. Only the cookie stored on the visitor's computer (etc.) is identified.

Anyone who wishes to visit the UAK website can do so even without cookies being stored. This is done by changing the settings of the visitor's browser. However, this may reduce the functionality of the website for the visitor.

Confidentiality

UAK treats submitted and collected personal data as confidential. Personal data accessed by UAK is thus not disclosed to any public authority or to any private company or individual, with the exceptions set out below.

Disclosure for the performance of contracts

Personal data may be disclosed to the extent necessary for UAK to fulfil its contractual obligations in relation to UAK's customers.

Disclosure in order to comply with a legal obligation

Personal data may be disclosed to the extent provided by law.

Disclosure after a balancing of interests

Personal data may also be disclosed after a balancing of interests in each individual case in order for UAK to be able to perform tasks of public interest, for example in connection with the investigation of suspected crimes or other irregularities, to prevent crimes or other irregularities or to ensure that provenance data or other object-related data of cultural historical value or important for the value of an object are preserved for the future. With regard to provenance data, information is not normally disclosed in such a way as to reveal the identity of individuals who are alive or recently deceased.

External service providers

Personal data may also be disclosed in cases where UAK engages third-party service providers to perform tasks on its behalf. However, disclosure to external service providers may only take place to the extent necessary for them to fulfil their tasks for UAK. It is also a prerequisite that these suppliers have a data protection policy that is at least equivalent to UAK's data protection policy with regard to the protection of personal data.

Consent

Personal data may be disclosed regardless of whether any of the above conditions apply if the individual has given his or her consent to disclosure. Consent given may be withdrawn in writing.

External marketing

UAK never discloses any personal data to third parties for marketing purposes, unless the individual concerned has expressly consented to such disclosure.

UAK employees and contractors

All UAK employees and contractors engaged by UAK for the processing of personal data have been informed of the confidentiality and have given a written undertaking to comply with UAK's confidentiality undertakings.

For how long time is personal data stored?

Personal data is kept for as long as necessary to fulfil the purposes for which it was collected.

If the individual concerned so requests in writing, the personal data collected will be destroyed immediately, to the extent possible taking into account UAK's needs to keep certain data in order to fulfil contracts entered into, fulfil a statutory obligation to provide information or the data must otherwise be kept by law or in order for UAK to fulfil a task in the public interest. In such cases, the data are kept for as long and to the extent necessary for the performance of the contracts, for the provision of the information required, for other reasons required by law (normally this means that the data must be kept for ten years) or for the performance of tasks in the public interest (in such cases the data may be kept for more than ten years).

Data of public interest mainly refers to data relating to cultural-historical documentation, cultural-historical provenance data and data that may be relevant to criminal investigations. The person who has provided such information to UAK consents to the data being stored for the purposes specified.

Where is the personal data stored?

Personal data submitted and otherwise collected will be stored in Sweden and/or another country within the EU, EEA or in the United Kingdom. Names and email addresses, but no other personal data, may also be stored in the United States, but only to the extent necessary for the purpose of sending newsletters and invitations. In such cases, the application of the same data protection as under the EU General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation)) has been provided for by agreement.

Right to information, complaints

Anyone wishing to obtain information about or rectification of their own personal data processed by UAK or that personal data provided will not be used for marketing purposes has the right to request this free of charge in writing to UAK at the following postal address: Uppsala Auktionskammare, Attention Data Controller, Box 184, 751 04 Uppsala, alternatively at the following e-mail address support@ uppsalauktion.se.

Anyone who has questions about UAK's handling of personal data or is dissatisfied with this handling can also contact UAK at the address given above.

Anyone who is still dissatisfied with the processing of personal data by UAK can lodge a complaint with the Swedish Authority for Privacy Protection (www.imy.se), which is the Swedish supervisory authority for the EU Data Protection Regulation. Anyone who is dissatisfied can also appeal to the supervisory authority in the country where he or she lives or works.

Language

This Data Protection Policy is available in Swedish and English. In the event of any discord between these, the Swedish version shall prevail.

This data protection policy has been adopted by the UAK Board of Directors and is valid from 8 April 2022.
